Sub: Fresh affiliation of Education College – orders issued – reg.

I am, by direction, to inform you that provisional temporary fresh affiliation is granted to Muslim College of Education, Thiruvithancode, Kanyakumari District for the academic year 2007-08, to offer the following course with the sanctioned strength noted below, subject to the fulfillment of the conditions laid down hereunder :

Course	Sanctioned strength
B.Ed.	100 (One hundred)

Conditions

1. The college should conduct classes for 180 days from the date of affiliation for holding examination at their cost.
2. The sanctioned strength permitted for the above course should be adhered to.
3. No financial commitment should be caused to the University and to the Government of Tamil Nadu.
4. The conditions stipulated from time to time should be fulfilled.
5. The College Committee / Governing Body should be immediately constituted and the same should be reported to this office immediately.
6. The fee from the students must be collected according to the fee structure framed by the Government.
7. The College should not collect any capitation fee or any other kind of fund from the students or from their parents for admission.
8. Admission norms, including rules of reservation quota, should be strictly followed.
9. Teachers should be appointed only on the basis of the recommendations of the Selection Committee constituted by the College.

10. The appointment order and joining report along with other copy of certificates shall be sent to this office for the appointment of Principal and Lecturers for obtaining qualification approval.
11. If the College is a co-educational one, at least one lady teacher should be appointed.
12. A copy of the Inspection Commission report is sent to you for perusal and necessary action.
13. The undertaking already given by the college to the University should be strictly adhered to.
14. Teaching and non-teaching staff should be paid the UGC / Government scales of pay with full allowances through nationalized Bank. Service Registers shall be maintained for the staff of the college.
15. A detailed report on the following points should be sent.
 - a) Formation of the College Committee / Governing Body.
 - b) Admission of students.
 - c) Date of commencement of the college.
16. Qualified Principal and Lecturers should be appointed as per UGC / NCTE norms immediately.
17. The qualification relaxation provision in the UGC rules may be availed by the College on the permissible grounds.
18. The norms stipulated by NCTE / Govt. / University should be strictly adhered to.
